It is not Decent.

In compliance with a request from a correspondent for our opinion as to the propriety of female nurses bathing male patients in the bathroom, we have no hesitation in saying that in no well-managed hospital or infirmary would such a custom be permitted for a moment. There should always be a bath-man, whose duty it is to bathe such patients as are well enough to take There can be no doubt whatever that such a practice as requiring female nurses to bathe able-bodied men must have the effect of lowering the standard of nursing in those institutions where it prevails, for no woman of refinement will consent to perform this office, and no parent who has any consideration for his daughter's feelings will permit her to remain on the staff of an institution where it is the custom. It is one thing to perform any office which may be required in the interests of the sick, it is quite another to undertake duties for which there is no reason. If a nurse is required to wash a male patient, the work should always be performed in the ward, the patient lying between blankets.
