Course in Hospital Economics. At the request of the American Society of Superintendents of Training Schools for Nurses, Teachers College offers a special course in hospital economics. The course has for its purpose the preparation of trained nurses who have the necessary qualifications for teachers in training schools for nurses. Its aim is eventually to attain uniformity in curriculum and training school methods, which shall make the standing of a trained nurse practically the same from any training school connected with a general hospital in the country, and also in the course of time to be able to supply thoroughly trained superintendents to take charge of hospitals and training schools.
