self with mince pies? It worried me very much, and I was truly relieved when Sister X, who was an old campaigner, raided all the lockers and unearthed the indigestible dainties. Then there was a friendly night nurse who would wake me up in the middle of the night, when I was convalescent, to have a cup of tea when she made hers, and tell me all the hospital gossip. But my principal recollections of my pro days are pleasant ones. There was the cold, the very plain food, the thousand and one personal disagreeables, but there was the fascinating and engrossing work (when the ward work was not too exacting), there was one's pride in one's hospital, one's interest in one's patients, and one's pleasure in one's chums, who shared one's joys and troubles and interests; whilst the lack of personal responsibility was a novel experience to those who, like myself, had had a great deal of it before they joined.

In spite of hard work, scanty time off duty, long hours, and stern discipline, I look back with pleasure on my probationer time, and shall always have a soft place for the stern old hospital that trained me.
