institution should be invited to send a representative.

Mrs. Fenwick said the difficulties in this connection were (1) that it was found a practical impossibility for busy country nurses to attend committee meetings in London, and (2) in the large majority of private nursing associations in the country the nurses had no self-governing powers; they were merely the employees of their committees.

- It was proposed by Miss Isla Stewart, and carried, that all Leagues of Nurses should be invited to appoint representatives to act on the Committee. Mrs. Fenwick said the principle that the nurses should send their own representatives was an important one.

The Executive Committee was then elected.
