## The Progress of State Registra= 226 200 tion.

The Nurses' Registration Bill was down for the second reading during the Evening Sitting in the House of Commons last Wednesday, and Sir Frederick Dixon-Hartland's blocking motion again appeared in the orders of the day. Several nurses interested in the Bill were very busy in the Lobby in the afternoon interviewing Members, many of whom expressed their sympathy with and entire approval of the principles of the Bill. The nurses' neat uniforms apparently brought the question of Registration before our legislators in a most practical way.

The R.B.N.A. Bill appeared amongst the notices of motions for Thursday, to be brought in by Mr. Claude Hay. We learn it is to be blocked at the instigation of the Central Hospital Council.

Referring to these Bills in its last issue, the British Medical Journal says that the opposition of this Council "is no doubt due to a dislike to any proposal to establish a central board which would diminish the independence of the nurse-training schools. The chance of either Bill being discussed in the House of Commons this Session must be very small, even if Sir F. Dixon-Hartland were to withdraw his opposition. The wiser course for those interested in the matter would probably be to endeavour to have both Bills referred to a Select Committee." That is a Committee of Members of the House of Commons.

The Legislation Committee of the National Union of Women Workers discussed on Wednesday morning the Nurses' Registration Bills. By invitation, Mrs. Bedford Fenwick, and Miss Annie J. Hobbs, Secretary of the R.B.N.A., attended the Committee and explained the various clauses, and pointed out the urgent need for legislation to create a Central Nursing Council with power to define the qualifications for a trained nurse, as at present no minimum standard of efficiency is required. The ladies mesent evinced great interest in the question.
