phyllin obtained. There are cases—of hemiplegia and paraplegia especially-where the weekly administration of a moderate dose of calomel or podophyllin will go far to save the patient from the dangers of auto-intoxication, as I have frequently had occasion to prove.

4. "Yes, yes, give him an aperient, nurse," and the doctor goes on his way. And then?

In the first place you must differentiate between private patients and hospital patients. The latter will as a general rule tolerate a far larger dose. But in either case it is the nurse's duty to observe for herself what is best suited to her patient's needs. She should also know how long each medicine will take to act as a general rule, and shortly in the individual case also. She will learn not to give eastor oil at night, to act as a sure disturber of her patient's rest. Cascara, calomel, rhubarb, or compound colocynth pill, on the other hand, will not act until the following morning. Senna mixture, sulphate of magnesia, jalap, with the effervescent alkalies are best given early, and all but

the first named with at least half a pint of water.
In cases of hæmorrhoids she will not give an aloes pill, nor a compound colocynth pill, which contains aloes. She will be resourceful and will recollect that massage, especially along the course of the colon in the direction of the peristaltic wave, will help to cure a case of obstinate constipation. She will give an enema, where aperients have failed, and in giving it will often have to recollect to first clear the rectum of scybala. She will know that a glycerine injection, an olive oil enema, a turpentine enema, and a starch and opium enema, all have their special uses. If castor oil and other draughts cause vomiting, she will produce pills and tabloids. She will never be dismayed, but out of a long experience will attain her end.

It is impossible to do more within the limits of one short paper than indicate possibilities. Experience and observation will prove the truest teachers. A. Lucy.
