A motion standing in the name of Sir James Crichton Browne, dealing with the composition of the Central Board to supervise the Registration of Nurses, was recently discussed at a meeting of the Border Counties Branch of the British Medical Association. It was as

beg to record their opinion that on any Central Board formed by legislative enactment to supervise the education, registration, and discipline of nurses, there should be medical representatives at least equal in number to the representatives of the nursing body."

The resolution has been referred to the The Cardiff Division and the Divisions. Portadown and West Down Division have approved of the principle of State Registration of Nurses, the latter "confiding in the Council to use its best efforts to secure due control of the profession in the government of the nurses."
