At the Annual Conference of the Council and representatives of the County Nursing Associations, affiliated to Queen Victoria's Jubilee Institute, held at the rooms of the Medical Society of London last week, at which Mr. R. B. D. Acland, K.C., presided, a discussion took place on school nursing, and **a** resolution was passed on the subject, in view of the anticipated compulsory medical inspection of school children. Other interesting questions discussed were the insurance of nurses against the liabilities under the new Workmen's Compensation Act, and the agreements of nurses trained by county nursing associations.

On the previous day a conference of 200 representatives of Associations affiliated to the Q.V.J.I. was held, by permission of the Duchess of Buccleugh at Montague House, Whitehall.
