nected with our Lying-in Charity; and as there are over two thousand of these cases in a year within a radius of a mile and a half round the Hospital, it is intended to employ a second Nurse in a similar manner.

"It has also been proposed to lend bags of linen to these patients at a small charge. The advantage of Trained Nursing for the extern cases cannot be overrated, and the results of the experiments have shown that it is not less a boon to the patients themselves than to those in attendance upon them. The number of Nurses attached to the Institution is now forty-four, as against thirty-four in 1888, and the demand for their services is steadily increasing; four hundred and forty-eight applications were received during the year, and Nurses have been sent to all parts of the United Kingdom, and to the South of France. It should be added that with the view of retaining the services of valuable Nurses, a special scale of remuneration has been introduced for every additional year of approved service. Mrs. Wilson has resigned the office of Lady Superintendent, and Miss Bower, who was for some years a Sister at Guy's, and lately Matron of the Huddersfield Infirmary, has been appointed to fill the vacancy."

Headdon, the energetic directress of the National Housewifery College, Riverdale, Newnham-on-Severn, is issuing a circular drawing attention to a desire to incorporate the college under the Companies Acts. Perhaps I cannot do better than give the circular in full as follows.

"National Housewifery College, "Riverdale,

" Newnham-on-Severn. "To our kind friends and helpers,-Finding the mortgage remaining upon the College a great burden, and acting upon the advice of friends (more particularly of Miss Buss, the North London Collegiate Schools, who has lately visited the College), who desire to see the work put upon a more public and business-like footing, and believing that such a step is necessary to widen its influence and ensure its permanent good, I am sending this circular to all our friends to say that we are prepared to incorporate the College, the Classes, and the Trade Department, under the Companies' Acts, 1862 and 1886, whereby the liability of the shareholders is limited to the amount of their shares, either as a company by itself, to be called 'The National Housewifery Company, or to incorporate it in conjuction with 'The Forsyth Technical College Company,' already started, as shall be hereafter decided. To take either step it will be necessary to issue eight hundred shares of £5 each to clear off the mortgage, open a London depot for the Trade Depart-Shareholders would have in their ment, &c. hands the full value of their shares in the house alone, which is a freehold property standing on two and a-half acres of land; and seeing that it can accommodate sixty students, that the demand for manuals and apparatus is likely to be large, and that the housewifery classes are rapidly increasing, it is anticipated that when it is placed
