Ruchill Bospital Enquiry.

The investigation into the administration and management of the Ruchill Hospital, Glasgow, was opened on Monday last by Sheriff Crawford. Miss Landles, the Matron, and Dr. Johnston, the physician-superintendent, who were present, were legally represented, as were the assistant resident physicians. Ten of the nurses were represented by Mr. H. P. Gordon Ferguson, and the Rev. D. W. Roberts appeared for seventy-two members of the Nurses' Protective Association. Three resident physicians gave evidence, and amongst the allegations made by them were that certain of the wards were overcrowded, the nurses overworked, and the hospital understaffed; that a nurse with no previous experience of diphtheria was put in charge of the diphtheria ward; that a nurse in charge of an enteric ward during the absence of the Sister had only been three weeks in the ward, and had had no previous experience of enteric fever, that some of the patients on milk diet got solid food, that many of the older nurses had left, and that apparently no attempt was made to keep them; that the supply of linen was inadequate; that natients lay in their own excreta, and in wet sheets; that restrictions were imposed upon the Sisters and Nurses by the Matron, so that certain information was withheld from the physicians; there was no system, and the patients were attended by nurses who had not the proper experience. An eight months' probationer having asked to be relieved of the charge of a ward, one of only five months' experience was substituted. That a patient who developed an acute attack of nephritis had been out of bed on two successive nights. That instructions that a patient's eyes should be bathed were not carried out. Subsequently the sight of both eyes was lost.

We shall hope to give a further report of this enquiry next week.

THE NURSING AND MIDWIFERY EXHIBITION. A committee of doctors, many of them women, are organising a Nursing and Midwifery Exhibition, to be held in the Cavendish Rooms, Mortimer Street, Regent Street, London, W., from April 28th to May 1st. It is hoped to have on view all the latest scientific inventions and improvements that have been recently produced for the advancement of knowledge amongst nurses and midwives. Lectures will be given each evening. We are very favourable towards exhibitionsthey can be made so educational-but if a nursing exhibition is to be a success experts should help to organise it, and we regret the omission of trained nurses from the Reception Committee. We hope this omission will soon be rectified.
