the first half of 1907. The Matron thought not, and she was entitled to her opinion. She was new to the hospital. The circumstances were such as prevented her having a fair chance. It was on his advice his assistants put their grievances in writing. These included not being consulted as to changes of staff, an insufficient number of nurses and sisters, inexperienced nurses in charge of wards and on ambulance duty. In the interests of efficiency they asked that an agreement might be come to concerning these matters.

In November and December additional nurses were obtained from nursing homes. The witness had introduced the present ambulance arrangement. It had been brought out that it interfered with the convenience of the wards, and he thought the introduction of some other system desirable.

DR. CHALMERS, Medical Officer of Health, repudiated the suggestion that the shortage of nurses was due to their fear of cerebro-spinal fever. It was quite contrary to their experience in Glasgow to have nurses refuse to volunteer even for an unknown disease. He thought registration had more to do with it. The Committee, recognising the advantages of nurses being registered, looked with favour upon their going away after three years and getting general training. Dr. Johnston had never remonstrated with him as to the overcrowding of the hospital. If he had he would have seriously considered the remonstrance

The Report of the Commissioners to the Local Government Board will be awaited with much interest.
