THE CENTRAL POOR LAW CONFERENCE.

The 36th Annual Conference of the Central Poor Law was held in the Council Chamber of the Guildhall on Tuesday and Wednesday, the 18th and 19th. On Tuesday, the Lord Mayor, Sir John Bell, took the chair, and formally opened the proceedings by extending a cordial welcome to the Delegates present. The chair was subsequently taken by Sir Edward Fry, the President, who, ia his address, dwelt upon some of the difficulties encountered in dealing with the problems of poverty. He pointed out that So ialism was making many demands-free education, amusements, the feeding of children, and the probable giving of pensions whether merited or not, would become more and more serious in operation and such demands had a tendency to increase out of all proportion to national resources of income. What must be guarded against was the destruction of family life and parental responsibility, deteriora-

tion of character, independence, and manhood. Mr. Bailward (late Chairman of the Bethnal Green Board of Guardians) read a paper on the subject for discussion, viz.: "The Relation of Legal Relief and Private Charity," dwelling at length on the past and present history of the ques-.

tion. Probably no other question had so muchexperience behind it, or had had more attention bestowed upon it than the relief of poverty, and now the Conference had to consider what were the respective functions and merits of public and private relief, and methods of co-ordination and co-operation.

Dr. Macnamara (Parliamentary Secretary, Local Government Board) addressed the Conference and congratulated Guardians on the improved conditions in the life of Workhouse children which might now be considered as humane.

The attendance at the Conference was larger than on any previous occasion, 232 Poor Law Unions sending delegates.
