In regard to the appointment of officials for the new Children's Infirmary at Carshalton, one of the Managers, Miss I. M. Baker, enquired why permission was not being asked to appoint a Matron as well as a Medical Superintendent for the new infirmary. The answer she received was that the one appointment was to the position of principal officer, and the other to that of chief Is it legal to evade the Poor Law officer. Orders in this way, because no special Order has been issued in respect to the Children's Infirmary? We doubt it. This is a matter upon which the Matrons of Metropolitan Asylums' Board Hospitals should have definite informa-
