## Distribution of Prizes.

AT THE ROYAL INFIRMARY, NEWCASTLE. A silver medal and some eight or nine prizes, provided by the Heath Trustees, were presented on the 20th November by Lady Ravensworth at the Royal Victoria Infirmary, Newcastle. Sir George Hare Phinipson occupied the chair. There were also present Lord Ravensworth, the Bishop of Newcastle, and Mrs. Straton, Mr. J. E. Woods, Sir Thomas Oliver, Dr. G. H. Hume, Sir Isambard Owen (Principal of Armstrong College), Miss Wamsley (Lady Superintendent), and others.

## The Motification of Consumption.

Mr. Fenwick, M.P. for Wansbeck, Northumberland, asked the President of the Local Government Board in the House of Commons recently whether, in connection with the proposed legislation for making compulsory the notification of consumption in the case of paupers, he could see his way to extend the proposal to the compulsory notification of all cases of consumption. Mr. Burns replied that the action he proposed to take in Poor-Law cases would be taken under the existing powers of the Local Government Board. He did not contemplate further legislation at the present time.

plate further legislation at the present time.

In New York, U.S.A., the notification and registration of all cases of consumption are now compulsory, and the result is that three-fourths of the 40,000 consumptives are under the direct surveillance of the Health Department. Free bacteriological examination of sputa is made in suspected cases, lectures are given in the public schools, municipal doctors and nurses visit consumtives at their own homes, and supervise their health. Free treatment is given in dispensaries and hospitals, and consumptives' rooms are freely

disinfected.
