even if it were desirable, of Parliament passing any such restrictive legislation. The Medical Acts do not make the registration of medical practitioners compulsory, nevertheless their moral and disciplinary force has been sufficient during the last fifty years to cause every medical practitioner of standing to register, and, under the influence of the General Medical Council—the central governing body set up by the Act—medical education and the status of medical men has been enormously improved. We look forward to the same beneficial results when a Nurses' Registration Act comes into force. Anyway there is plenty of choice in Registration Bills, as including the R.B.N.A. Bill, there will be three before the coming Parliament. The more the merrier.

Irish Murses' Association.

An extraordinary general meeting was convened on Saturday night, 6th inst., at the Rooms, 86, Lower Leeson Street, to consider the question of a pamphlet recently issued by the Editor of the Nursing Mirror, and a plebiscite form re "Nurse Registration."

It will be for your Association to put the public on its guard against this manufactured return, and to show up the names of the parties at the back of the opposition, as well as the dodges resorted to, to carry on the game, and to explain not only to the nurses but to the public the motives at play to exploit the nurses at the expense of their own welfare.
