where Miss Dickson had been Head Nurse, as the Sisters were then termed, she was put in charge of the Students' Wards, where her work will long be remembered gratefully by past students. This position she occupied until March, 1907, when she retired under the age limit with a pension. Her activity, however, was by no means exhausted, and she established a Trained Nurses' Home and Association, which she carried on successfully up to within a few weeks of her death.

She was a woman of a kindly and well-balanced disposition, who pursued her work in a quiet, unostentatious manner, content to do her very best from day to day, an excellent nurse, with a clear, cool head, and clever, deft hands, which enabled her to handle patients most skilfully, and carried the art of bandaging to perfection, and which she taught so successfully to succeeding generations of Royal Infirmary nurses.

Her memory will always be affectionately retained by those with whom she came into contact. Of her it may in truth be said :---

"Life's work well done, Life's race well run,

Life's crown well won."
