She carried with her the good wishes of the citizens and of the sick poor of Dundee, to whom she had been a ministering angel. The Rev. Dr. C. M. Grant said that their feelings to Miss Mackay were those of gratitude for the past and good will for the future. On behalf of the nurses of the Caird Home ex-Lord Provost Hunter presented her with a pair of beautiful candlesticks. In acknowledging the gifts Miss Mackay said she thanked them all from her heart for what they had done.

## Nursing Echoes.



The second annual meeting and reception of the Army and Navy Male Nurses' Co-operation, at which Princess Louise Duchess of Argyll, accompanied by the Duke of Argyll, was present, was held at the Grafton Galleries on Monday afternoon, and was very bright and animated.

At the foot of the stairs two of the nurses of the Co-operation, looking very smart in their spotless white coats, were stationed to collect tickets, and programmes and tea tickets were distributed, and donations received by girls picturesquely dressed.

The annual report showed that satisfactory progress had been made during the year, and 300 cases had been nursed by the members of the Co-operation against 108 during the previous year. The staff now consists of 33 men, and it is hoped before the winter season closes 50 will be employed. When the members reach 100 it is confidently expected that it will be self-supporting. It was reported that her Majesty the Queen had shown her interest in the work by sending a donation of £100 in furtherance of the cause. The residential home which now accommodated 9 men had proved of great value. Dr. Howard Tooth, C.M.G., was Chairman of the Sub-Committee upon which two of the nurses had seats as representing the Co-operation. Miss Ethel McCaul, R.R.C., the Hon. Secretary, was warmly thanked for her work on behalf of the Co-operation, by several speakers.

The Duke of Argyll, who referred to the great interest taken by the Princess in the enterprise; spoke of the importance of having soldier nurses near the fighting line in action, so that their training in time of peace was of infinite value; moreover, to have an efficient reserve it was important that the men should be kept in harness. Colonel Sir Edward Ward, K.C.B., who proposed a vote of thanks to H.R.H. Princess Louise, said that Mr. Haldane and his colleagues at the War Office felt that the work of the Co-operation in providing employment for retired soldiers was of great value. He further said that at the request of H.R.H. Princess Louise he had officially inspected her Hospital for Convalescent Soldiers at Rosneath. He saw the books, and enquired into the management as closely as he was able,
