LECTURES ON HISTORIC LONDON.

The Lectures on Historic London, which have proved of entrancing interest, given to the League of St. Bartholomew's Hospital Nurses, by Mr. Allen S. Walker, Hon. PUBLIC ENQUIRY NECESSARY.

At a meeting of the Executive Committee of the Workhouse Nursing Association, held on December 17th, the following resolution was passed:—
"The Committee desire to place on record the expression of their great regret that the President of the Local Government Board has declined to order a public inquiry into the recent calamitous occurrence at the Hemel Hempstead Workhouse which resulted in the deaths of certain patients; and they hope that, considering the gravity of the occurrence, this decision will be reconsidered." It was also resolved that the secretary be instructed to send to the Local Government Board a further memorial on the subject.
