Amongst the summonses taken out by the London County Council recently, under the provisions of the Education Acts, were two against the father of two children in Walworth for omitting to cause them to attend school on July 5th and divers other dates. Mr. Carter, from the Solicitor's Department of the Council, who prosecuted, said the question was whether it was reasonable or not for the school authorities to require a child to be examined so that it might be ascertained whether it was in a proper condition to associate with other children. Mr. Washington, for the defence, said they were summoned for refusing to send the children to school, but were excluded by a letter from the County Council saying: "You shan't send your children to school. How could they be summoned for not sending them? Miss H. L. Pearse, Superintendent of School Nurses under the London County Council, testified that she saw the two children at school on two occasions, and at her request they lifted up their hair but were not examined. She instructed the head mistres; to exclude them, acting on instructions that the children should be excluded if they refused to be examined. A fine of 10s. and 10s. costs upon each summons was imposed by the magistrate, Mr. Horace Smith. There can be no doubt that it is the duty of the Education Authorities to satisfy themselves not only of the sanitary condition of the school buildings, but also that the children who attend are in a proper condition to associate with their companions.
