Tooth brushes are supplied at the cost of 5 cents. For linen roller towels, sanitary paper towels have been substituted; also sanitary soap dishes.

Paper cups and sanitary drinking fountains, lavatory seats scrubbed with soap and water, and sponged off with carbolic lotion 1-20.

THE MARY WHITE MEMORIAL FUND.

Dr. Cromie, the acting treasurer of the Mary White Memorial Fund, reports that contributions amounting to £400 have been received. Such a substantial response to the suggestion for providing a memorial to the late Superintendent of the Northumberland County Nursing Association shows how highly her character and services were appreciated. It has been agreed that a fund be constituted, to be called "The Mary White Fund for Sick Nurses," and that the object of the fund shall be to provide temporary help for nurses working under the Northumberland County Association, who, from illness arising out of their occupation, may be in need of rest or special treatment, and that such help shall be given in the form of grants out of the annual income of the fund. A yearly income of £14 will be available for the purpose.

A committee of management was elected with Miss Taylor, of Chipchase Castle, as secretary, and Dr. Cromie as treasurer.
