in camera a proposition by Mr. Howel Davies, adjourned from the June meeting :---

"(a) That a sub-committee be appointed to consider all applications from candidates for probationer nurses, who shall recommend candidates to the House Committee, as and when • vacancies occur, and that all regulations to the contrary be rescinded; (b) that a register of candidates be kept by the matron and submitted to the sub-committee when required."

We learn that a most animated discussion took place for nearly an hour and a half. Mr. Davies pointed out that at present the selection of the probationers lay practically in the hands of the matron, which, he considered, was inadvisable.

Drs. Lancaster, Brook, Knight and Elsworth opposed the adoption of the proposal. In the result Mr. Davies' proposal A was defeated by a narrow majority, but his proposal B was carried.

Had (a) of the proposition been adopted, we imagine, a notice of motion would have been handed in to rescind the necessity for a matron -as it appears superfluous to pay and employ an officer, whose chief duty is to be undertaken by a sub-committee. The chief nursing officer should select and recommend to the committee for appointment all subordinate nursing offi-Unless she possesses the power and cials. discrimination to perform this duty, she cannot maintain discipline, nor should she hold office. The tendency in these days of hospital managers to minimise the matron's rightful 'authority and appoint weak women who are satisfied to accept a salary and let things slide, is a sign of degeneration in hospital management, and an evidence of a spirit of intolerance in so far as women's skilled work is concerned. Imagine the household conducted upon this principle. The Matrons' Council might well define the relations which should exist between the committee of a public hospital and the chief nursing officer. We believe it would be found very useful by conscientious hospital governors.

The great work done by Miss Fraser in establishing a thorough system of nursing at the Dunedin Hospital, is recognised throughout New Zealand with gratitude, and is a great advantage to her successor, Miss Mackenzie, who thinks that the training is so up-to-date that it would compare favourably with any of our hospitals in Britain. Dunedin she finds a lovely "garden city," built on the hillside, and says: "I have received nothing but kindness on every hand; it is difficult for me to realise

that I am so far from home." On the journey out Miss Mackenzie visited the hospitals at Adelaide, Melbourne, and Hobart.

## THE MIDLANDS ASSOCIATION OF MATRONS AND SUPERINTENDENTS.

The first meeting of the session will be held at the General Hospital, Birmingham, by invitation of the Matron, Miss Musson (President of the Association).

The Association was formed a year ago, for the purpose of social intercourse and the discussion of professional topics, and numbers at present about 50 members.
