which prevails concerning this terrible danger to health.

A cupful of petrol placed in a room will destroy all flies which come within reach of the fumes. and if held underneath flies on the ceiling will instantly kill them. But the inflammability of petrol makes it a somewhat dangerous remedy, and it should never be used in a room containing

a light or a fire.

STATE REGISTRATION IN VICTORIA.

Issued with the July number of Una, the journal of the Royal Victorian Trained Nurses Association, is a supplement of its Scheme for State Registration of Nurses, as adopted by the Council of the R.V.T.N.A., which came before the Annual Meeting on August 19th, and of which we shall receive a report in good time. The Scheme provides for the constitution of a "Nurses' Registration Board of Victoria," composed of eleven persons (a) one Government nominee, (b) two medical men nominated by the local branch of the British Medical Association, (c) three hospital representatives, (d) two matrons of hospitals, to be elected by the Council of the R.V.T N.A., and (e) three representatives of the nurses, elected by the nurses themselves.

The Powers and Duties of the Board are almost identical with those sought for in our own Nurses Registration Bill, but includes the registration and control of general nurses, and midwifery nurses (midwives) The standard of training, after one year's term of grace, for general nurses is to be three years in a recognised training school, and for midwifery nurses six months, in addition for general nurses, and twelve months if for midwifery alone. There is no provision for the registration of mental or male nurses under any other conditions.

We congratulate the R.V.T.N.A. on pushing nursing legislation forward, and hope the Governor in Council will soon perform the pleasing duty of appointing the Nurses Registration Board.

We also hope that when Victorian nurses have legal status they will take a more active part in conducting, and influencing the policy of their professional organ, when presumably the partisan reports (such as that of our recent Deputation to the Prime Minister) will not be reprinted from the quack anti-registration publications of Sir Henry Burdett, but from the official organs of the Nurses Registration Society and the British Medical Journal. It is high time Australasian nurses realised how unethical it is that their organs should be used to propagate anti-registration heresies, written purely for commercial purposes, and thus injure their colleagues at home whose long and honourable struggle for higher standards of nursing has now become historic.

We are pleased to note that; since her visit to England, and her personal inquiries into nursing politics here, Miss Gretta Lyons, a member of the R.V.T.N.A., is attempting to place the truth before them in Una.
