## THE PROGRESS OF STATE REGISTRATION.

The Royal Victorian Trained Nurses' Association have adopted a scheme for the State Registration of Nurses, and recently a deputation from the Association, introduced by Dr. A. Anderson, waited on the Minister for Health (Mr. Hagelthorn), asking that a Bill for registration be introduced into Parliament.

Dr. J. W. Springthorpe said that they only desired efficiency. The two Bills—the Midwifery and the Trained Nurses Bills—should be amalgamated, for the proper registration of nurses, so that only those properly trained could work in the profession. The deputation wished to lay the case before him, and would be willing to come again, when he (the Minister) had been able to give it full consideration. He hoped that a Bill would be passed, for which the whole State would be thankful.

Mr. Hagelthorn, in reply, said that the proposal deserved every consideration. There was no objection to registration, but it must not be forgotten that there were poor people who could not pay large amounts, and also there were unregistered women, who were able to do good work in attending patients. It might not be possible to pass a comprehensive Bill in this Parliament, but every consideration would be given to the matter.

The draft Bill provides that no person whose name is not on the Register of General Nurses, shall after a specified time, for gain, attend or undertake to attend any sick person, under a penalty—and no person whose name is not on the Register of Midwives shall after a specified time, for gain, attend or undertake to attend any lying-in woman, under penalty. It is these penalising clauses to which no doubt the Minister of Health alluded.

The Pacific Coast Journal of Nursing reports an inspiring paper read by Miss Anna Jamme before the State Nurses Convention at Santa Barbara, on the "Meaning of Nurses Registration Law to the State," dealing with the new Act just brought into force in California, which ends with the sporting paragraph, "And now, Madame President, may we not adopt
