NURSING ECHOES.

Sir George and Lady Wyatt Truscott are most kindly giving an Evening Party at 87, Lancaster Gate, W., on December 6th, to meet the Committee and Nurses of the Territorial Force Nursing Service for the City and County of London. This Service was organized during the reign of Lady Wyatt Truscott at the Mansion House, and she has always taken the warmest interest in its welfare.

We pointed out last week that the London County Council had altered its original suggestion for the annual licensing of Nursing Homes, and Massage and Manicure Establishments, and now proposes to obtain statutory powers of registration, a change distinctly for the better. The Midwives Act Committee now recommend that the promotion of legislation in regard to the regulation of lying-in homes shall proceed on the same lines, such places, and the person or persons in charge thereof being registered by the Council instead of being licensed.

We have always been in favour of the registration and inspection of nursing homes, and have repeatedly urged the necessity for legislation in this respect.

But it must be realized that if such registration is to be effective their inspection must be carried out by professional persons, who understand what they are inspecting. To utilize, as suggested, the inspectors already employed in connection with theatrical and other employment agencies would be quite useless, unless they are either registered medical practitioners or certified and experienced nurses and midwives. While the majority of highly skilled nurses at present providing and superintending nursing homes, for the great benefit of the public, would welcome inspection by experts, they would justly resent inspection by persons who have not mastered the elements of the skilled professional work they are called upon to inspect.

The Nurses' Co-operation will be "At Home" at the Nurses' Club, 35, Langham Street, W., from 3.30 to 5.30 on December 4th, when the Show of the Nurses' Needlework Guild will take place in the Club Room.
