A General Meeting of the League of St. Bartholomew's Hospital Nurses was held in the Clinical Theatre on Saturday, November 29th; the President, Miss R. Cox-Davies, was in the chair. It was arranged that the series of lectures on pictorial art should take place after Christmas on Tuesday evenings, at 8.15 p.m., the lectures to be given by Professor Spencer, of the Royal School of Art. In the event of this hour clashing with that of Lenten services, the last two of the series of six to be given at 6 p.m. on Thursdays. Miss E. B. Kingsford, in a letter to the Hon. Secretary, and personally, brought to the notice of the League the decision of the National Council of Nurses, at its meeting on November 27th, to act upon the suggestion of Sir Victor Horsley that the members of Nurses' Leagues should endeavour to collect signatures of qualified nurses to a Petition on behalf of State Registration of Trained Nurses, and conveyed to the League of St. Bartholomew's Nurses, as one of the affiliated Leagues, an invitation to assist in the scheme. League was in contact with nurses all over the world, and if its members would act as missionaries on this subject they might do much good work. The suggestion was supported by Mrs. Shuter, and also by the President, who considered it desirable that a list should be published which might counteract the influence of that circulated by the anti-registration party, which was by no means as valuable as it was made to appear. The proposal was received most sympathetically, members expressing a desire that the Hon. Secretary might be supplied with forms which would be available for their use.
