FEVER NURSES' ASSOCIATION.

APPOINTMENTS.

The following circular dealing with the question of the salaries of Fever Nurses has been drawn up by the Fever Nurses' Association and sent to the Fever Hospital Committees of the United Kingdom through their respective officials.

SIR,—I am instructed to forward to you the ensuing Resolution, adopted by the Executive Committee of the Fever Nurses' Association, as the result of a reference from the last Annual Meeting :-

"That in the opinion of the Fever Nurses" Association, the following are the minimum salaries which should be paid to Nurses holding the specified positions in Fever Hospitals :-

Ward Sister.—£38 per annum, rising by annual increments of £2 to £44;

Staff Nurses.—£28 per annum, rising by

annual increments of £2 to £34;
Probationer Nurses.—£18 per annum for the first year, and £20 for the second;

and that indoor uniform be provided in each case in addition to the salary."

I am also instructed to state that the Resolution is the result of an enquiry recently undertaken by the Association as to the salaries which are paid by the various Public Authorities throughout the Kingdom, and is being issued in this circular form to the Managers of Fever Hospitals generally.

I am to ask that you will be good enough to bring it to the notice of your Hospital Committee.

The Fever Nurses' Association trusts that in the event of the salaries paid to your nursing staff being less than the minimum defined in the Resolution, your Committee will see its way to increasing them at least to that minimum.
