was the same. It was entirely indefensible, and it was to be hoped that King Edward's Hospital Fund for London would support this view, and take steps to prevent such expenditure in the future.

No amendment having been proposed, the Resolution was put to the meeting and carried unanimously.

Miss E. Pell Smith then proposed a vote of thanks to the chairman, not only for presiding at the meeting, but for her work in support of the Registration Cause at all times-it was impossible to say how much nurses owed her. This was carried enthusiastically by acclamation.

The meeting then concluded, and, on the hospitable invitation of Mrs. Walter Spencer those present adjourned for tea to 2, Portland Place, which was the more appreciated as the meeting had been long and animated.

A most interesting guest was Miss Elizabeth M. Burns, R.N., one of the passengers rescued when the *Titanic* foundered, who renewed several friendships made at the Buffalo Congress, U.S.A., in 1901; and had much to tell of nursing pro-gress in America.

A MATRON'S LIBEL ACTION.

Miss Elizabeth Birnie Couper, Matron of the Clackmannan Infectious Diseases Hospital, Alloa, who, in the Court of Session, Edinburgh, last year, brought an action for libel against Lord Balfour of Burleigh, which was eventually dismissed, has now produced fresh evidence and claimed a trial by jury.

Lord Dewar stated that the substance of the case presented by Miss Couper was that at the defender's request the charges he made against her had been investigated on three separate occasions by three impartial tribunals, and she had been declared innocent on all three occasions ; yet the defender would not acknowledge her innocence, but persisting in accusing her still.

The defender's position was that he made the statement complained of on a privileged occasion, and without malice, and was, therefore, under no legal obligation to withdraw anything he said.

His Lordship, who gave judgment and allowed the issues for the trial of the action, said that the question whether the pursuer was entitled to such a trial depended upon whether she had stated on record facts from which, if proved, a jury might reasonably infer that the defender was not acting in the public interest but from some improper motive. He thought if the considerations which weighed with him were proved to the satisfaction of the jury they might quite reasonably reach such a conclusion. He considered that the occasions on which the pursuer relied were privileged, and that, therefore, the word "maliciously" must be inserted in all the issues.
