Universities and colleges from all over the United States and from other countries sent representatives to Albany to take part in a most impressive ceremony. Miss Goodrich writes : "We feel that Dr. Finley's appointment is a matter of great moment to us. The vesting by New York State of the control of its educational system in the Regents of the University is unique, and their standards, and their conclusions concerning educational problems have weight all over the country. . .

You will appreciate how grateful we were to Dr. Finley when he included in his inaugural address a brief reference to the nurse's place in the educational system. As the *Tribune* puts it: "President Finley is going to make New York understand that this University does touch education at every point; and that it has not only to do with the training of the child in kindergarten, in common school, in high school, often in college, but with, as he puts it himself, 'The whole of education, from the training of the nurse who receives the newborn child to the researches of the scientist who lives out upon the utmost verges of the known.'"

THE PASSING BELL.

We regret to record the death of Miss Randall, a member of the nursing staff of the Victoria Hospital, Southend-on-Sea, who died on February roth in the hospital, as the result of burns. Miss Randall was dressing an amputation patient, formerly in the hospital, at his own home, when her dress came in contact with a gas stove and ignited. In order to avoid alarming the patient she rushed from the room, with the result that her injuries were more serious than would otherwise have been the case. This is the second instance, recently, in which a nurse's first thought, on an accident occurring, was the welfare of her patient, her own death resulting in consequence.

We may be sure that a nurse who thinks first of her patient in such alarming circumstances acts in accordance with the principles which have actuated her in her daily life.
