

congratulations on the appointment of Sir Ronald Munro Ferguson to the position of Governor-General in Australia; from Miss Cutler, Hon. Secretary League of St. Bartholomew's Hospital Nurses, notifying that Miss Milne had been nominated to succeed Mrs. Shuter as the delegate of the League on the Executive Committee; and from Miss Waldron, Secretary of the Leicester Royal Infirmary Nurses' League, asking the Society to consider the question of an alternative delegate. It was agreed to refer this letter to the Annual Meeting. A letter was received from Miss Norah E. Green, Secretary of the National Union of Women Workers of Great Britain and Ireland, notifying the Society that the Annual Meeting of the National Council of Women of Great Britain and Ireland will be held in Bristol from October 12th-16th, and reminding it that it is entitled to appoint a representative to serve on the National Council for one year. The President was nominated, and consented to serve.

A letter was also received from Miss Edith C. Harvey, Hon. Secretary of the Legislation Sectional Committee, enclosing the text of two resolutions for submission to the National Council of Women at its meeting at Bristol on October 15th, and inviting the support of the Society for the Resolutions so as to secure them a place on the agenda. The first resolution reaffirms that passed by the Council on October 14th, 1908, in favour of State Registration of Nurses with the addition:—

"Further, that in view of the majority in favour of the first reading of the Nurses' Registration Bill in 1914, the Prime Minister be respectfully urged to grant facilities for a similar Bill next Session."

The second resolution, which is to be brought forward if the progress of the Nurses' Registration Bill through Parliament renders the first unnecessary, "urges upon Borough and County Councils and other public authorities the desirability of appointing women police officers, especially in order to ensure the protection of women and children in public places, and to assist in the conduct of criminal cases in court dealing with women and children."

It was unanimously resolved to support both of these resolutions.

A letter was also received from Miss Wyatt Papworth, M.A., Secretary of the Women's Industrial Council, asking the support of the Society for Resolutions submitted by that Council. It was resolved to support a Resolution calling upon the Government to make grants in aid of Local Public Health Authorities for the medical inspection and medical treatment of infants and children under school age."
