STATE GRANT FOR NURSING.

The President drew attention to the fact that provision had been made in the Budget for a substantial sum to be set aside towards the provision and training of nurses for the insured sick under the National Insurance Act. The Hon. Secretary was instructed to forward the following resolutions to the Chancellor of the Exchequer and to Dr. Chapple, M.P.

RESOLUTIONS.

I. The Society for the State Registration of Trained Nurses learns with the utmost gratification that the Government has decided to grant a substantial annual sum to help to provide and 'train an adequate supply of nurses for the sick poor in their own homes.

In order that the nursing education, and efficiency, of nurses subsidized by State funds shall be guaranteed, this Society urges upon the Chancellor of the Exchequer the importance of facilities being granted by the Government, at the earliest possible date, for the second reading of the Nurses' Registration Bill now before the House of Commons.

Further, the Society for the State Registration of Trained Nurses begs to offer its thanks to the Right Hon. David Lloyd George, M.P., Chancellor of the Exchequer, for having voted with the majority of 228 in support of the first reading of the Bill in the House of Commons on March 3rd.

II.

That a copy of the foregoing Resolution be forwarded to Dr. Chapple, M.P., with the request that, should occasion arise, he will give publicity to the Resolution in the House of Commons.
