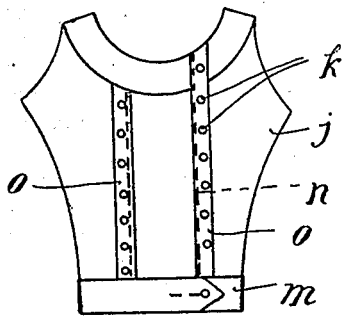


end of pregnancy, in spite of the alteration in the figure, no alteration in the gown (beyond the use of the extending press buttons) is required.

The price of the gown made for Lying-in Hospitals is extremely moderate: 7s. 6d. to



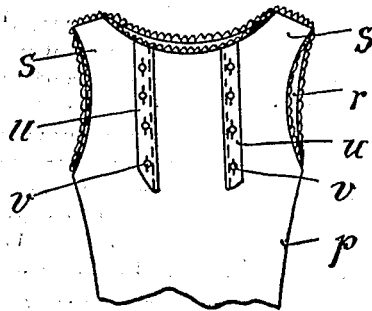
NURSING UNDER BODICE.

Another point is that the approach to the breasts is so easy, and there being no pressure, there is no possibility of an escape of milk, and the middle part of the gown being closed, the mother cannot take cold.

POSTER PARADE PROTEST.

AGAINST MISUSE OF NURSES' UNIFORM BY IMMORAL PERSONS.

Miss B. Kent wishes us to notify that Nurses are cordially invited to join the Poster Parade Protest against the Misuse of Nurses' Uniform by immoral persons. She considers that if outdoor uniform is worn, it will mark the fact that it is a nurses' agitation, but that all nurses will be eligible to parade, and that if they prefer it, mufti may be worn. The essential thing is that the Parade should be well supported and impressive, and she greatly hopes a good number of nurses will have the courage of their opinions and take part in the demonstration.
