Miss Ard Mackenzie expressed, as she had a perfect right to do, the views of an expert on a professional problem with which she is thoroughly conversant. We regret that she should have been subjected to discourtesy on this side of the Atlantic on that account, and beg to assure her that the columns of this journal are open to her if she wishes to deal with the subject further.
