POOR LAW OFFICERS AND THE COLLEGE OF NURSING.

We learn from the Poor Law Officers Journal that the Parliamentary Committee of the Poor Law Unions' Association "are continuing to press the promoters of the College of Nursing, Ltd., and its associates for a definite statement of their intentions as regards the decision of the Association." The Association requires a large share of representation on the Council. "We must not fail either to recognise quite fairly," the article continues, "that it is a request, and a repeated one, which proceeds from a representative public body to a private one which has not so much as a shadow of a title to public representation. know that there are chartered companies which have been founded with control over material matters, but can anybody produce an example of a limited company which has been given control over a public service that is concerned in such far reaching consequences as those which are bound up in the question of life and death which affects many thousands of the public, men, women and children? The position being what it is the inquiry may well be made which would require such an answer from Parliament as would state the ground on which the Legislature could furnish any limited company with power to decide who should or who should not control the care of many thousands of our fellow citizens."

AN INACCURATE STATEMENT.

Speaking recently at a meeting of nurses at Queen Mary's Hospital, West Ham, the Honble. Arthur Stanley said at present no society had any legitimate claim to represent more than a thousand or two thousand nurses, and the profession probably numbered 40,000 to 50,000.

We presume Mr. Stanley forgot the existence of

the Central Committee for the State Registration of Nurses the federated membership of which at its lowest computation numbers 10,000 nurses, who have been working and paying for registration for many years, to say nothing of the members of the various Leagues of Murses who support the Society for the State Registration of Trained Nurses. And it must be remembered that these nurses have come out and agitated for reform, often unsupported by their Matrons and in opposition to their Committees.

To compare these courageous pioneer workers with any number of thousands of nurses who may

be influenced, if not coerced, by committees and matrons to join the College of Nursing would be very_unfair.
