### THE MIDWIVES (IRELAND) BILL.

The Irish Nurses' Association has taken effective action to secure that the views of Irish midwives shall be considered in relation to the Midwives Bill for Ireland, and their friends in the House of Commons got a blocking motion in, until the Association could consider the Bill, which was not procurable until it had been introduced. This policy is supported by the Royal College of Physicians of Ireland, who have also appointed a sub-committee to deal with the amendments desired by the Association.

As we last week notified, the principal amendments desired by the I.N.A. are:—(1) a large increase in the number of midwives on the Central Midwives Board, (2) they consider that inspection should be carried out by the Central Authority, not by the Local Authorities. They are further of opinion that the Act cannot be administered on a guinea fee, as indeed has been abundantly proved by the history of the English Act, whose finances have to be supplemented out of the rates.

We have every sympathy with our Irish colleagues in their desire to have the finances of their Midwives Act arranged on a basis to cover the expense of its administration.

### IN MEMORIAM.

The death of Mr. E. Parker Young, L.S.A., for so many years a highly esteemed and valued member of the Central Midwives Board, which took place on Monday last, will cause widespread regret, not least among the members of the press, who greatly appreciated his courtesy and kindness.
