will find everything cut and dried without their consent. It considers that the interests of their Overseas colleagues have been protected to the utmost by the Trained Nurses' Association, and a vigilant eye kept on the progress of the Bill, which provides for uniform registration throughout the Union, compulsory registration of trained nurses and midwives, and the punishment by imprisonment of all unregistered persons who practise nursing and midwiferv; and it has every reason to believe that provision will be made for the representation of trained nurses on the General Medical Council.

That is the position in a nutshell. The nurses are to be governed by the General Medical Council with, possibly, a nurse or nurses upon it.

At present, nurses in South Africa are free, but if placed under the control of the General Medical Council, with registration enforced as compulsory, if they do not approve the rules made for their control they must either unwillingly submit, or must discontinue the practice of the profession on which they depend for their living, on pain of punishment by imprisonment! We cannot agree, therefore, with our contemporary that, in this event, "South African nurses on service overseas... will return to find nursing conditions a great deal better and more comfortable than when they left." An independent Governing Body, and govern-

An independent Governing Body, and government by consent, are the first essentials for any skilled profession, and legislation which does not provide this modicum of justice for trained nurses is dangerous to the freedom of their class. We advise every nurse to oppose any Bill which does not specifically provide for self-government.
