3. What would lead you to think that delay after the rupture of the membranes was due to obstruction ?

4. By what signs would you know that a baby is not thriving? How would you ascertain the causes ?

5. What signs would lead you to suspect that a woman might be suffering from syphilis ? How may this disease affect the mother and the child ? How would you endeavour to protect your self and others from this contagious disease ?

6. Under what circumstances do the rules of the Central Midwives Board require that the midwife should notify the Local Supervising Authority ?

## **EXAMINATION PAPER.**

The following are the questions set at the examination of the Central Midwives Board for Scotland on April 29th :--

1. Define the various stages of labour, and give three causes of delay in the first and second stage respectively.

2. What is Sepsis ? How can it be prevented, and when it does occur, how should it be treated ?

3. What points would you inquire into on visiting the mother and infant during the early days of the puerperium ? What conditions may give rise to elevation of temperature on the third or fourth day?

4. Postpartum Hæmorrhage. What are the conditions leading to this? How are they to be avoided? Why is the danger so great? How would you treat a case if postpartum hæmorrhage occurred ?

5. Mention some of the difficulties, connected with the breast, that may arise when a mother is nursing a child. State how you would deal with them.

6. Describe fully the management of a child born at the end of the 30th week of pregnancy.

## PENAL CASES.

A special board meeting of the Central Midwives Board for Scotland was held recently at 50, George Square, Edinburgh, the office of the Board, for the hearing of penal cases.

Arising out of an investigation instructed on a report by the Local Supervising Authority of the deaths of two patients from puerperal septicaemia, two certified midwives—No. 921 and No. 1163— appeared in answer to the charges of failure to send for medical assistance and negligence in keeping registers of cases, records of pulse, temperature, &c., as required by the rules.

On the conclusion of the hearing, the Board deliberated in camera.
