Corporation, and thus be compelled to join the College, as provided in its Constitution, whether they approve of it or not? So far, only one official, Mr. F. G. Hazell, the General Superintendent and Secretary of the Manchester Royal Infirmary, regrets he has "no information to afford you relative to the subject matter of your letter." This reply is in the best Manchester Royal Infirmary style—high and haughty. We must, however, beg to remind Mr. Hazell that it is also a public institution, supported by public funds, and that the public has a right to be informed upon what terms it admits probationers, and the manner in which they are treated. Probationers are public officials, and not the domestic helots of either a committee or their fellow officials. It may be necessary to refer to this matter upon a future occasion, when we deal with the replies received as a whole.

# AN INACCURATE STATEMENT.

We note a letter from Miss G. Cowlin, the Assistant Secretary of the College of Nursing, in the Hull Daily Mail, in which she supports the charitable patronage and interference by the committee of actresses calling itself the British Women's Hospital Committee, in our professional organisation. Incidentally Miss Cowlin states that the nurse members of the College are "now electing their own Council by postal vote." That is not a true statement. The nurse members are now being permitted to elect 12 out of the 36 members of the nominated College Council, and this after the whole organisation and the Rules to which they have to conform have been agreed

Responsible officials should be careful to be accurate in making public statements in a controversy with their professional colleagues. Let the lay element draw the long bow if thought justi-fiable in this controversy, but not members of the nursing profession.

## NO MONOPOLY OF NURSING.

Sir Arthur Stanley visits Sheffield on Friday, 24th inst., in support of the College of Nursing Ltd. The Sheffield Daily Telegraph states that "the promoters look forward to the time when all trained nurses will belong to the College, and when those who are in need of nurses will draw only upon those who are connected with the institution."

Just so, and it is against this monopoly of the control of trained nurses and their work by their employers that we independent members of the profession are fighting. We must have freedom of contract or servitude—and the sooner trained nurses realize this the better.
