The Annual Meeting of the Royal Corporation is, as already announced, to take place on Thursday, June 13th, at the Medical Society's Rooms, 11, Chandos Street, Cavendish Square, W., at 3 p.m. The President will be in the Chair, and the Report will, no doubt, be of great interest. The fact that the Association has decided to retain its Royal Charter, and not become absorbed into the College of Nursing, is a matter of very farreaching importance—much more so than the majority of nurses realise. The more interest the nurse members take in their own Association, the more they will realise how all-important it is to retain the powers granted to them in their Royal Charter by Her late Majesty Queen Victoria.

# THE SOCIETY FOR THE STATE REGIS-TRATION OF TRAINED NURSES.

Mrs. Bedford Fenwick has been invited to address the National Party on "State Registration of Trained Nurses as One of the Problems of the Day," and will do so at a meeting on Saturday, June 15th, at 64, Victoria Street, S.W.

It is earnestly hoped that members of the Society have kept the afternoon of Thursday, June 20th, free to attend the Annual Meeting. This Society drafted the first Nurses' Registration Bill in 1904, which was passed by the House of Lords in 1908, but which, owing to the opposition of the Nurse Training Schools, has been held up in the Commons. Now, however, that many of us have votes, and the Labour and National Parties have conscientious convictions as to the rights of the wage earners, our chances of just legislation in a modern Parliament are most hopeful, if only the nurses are true to themselves, and do not permit themselves to be used as pawns for an Employers' Bill.
