enced and competent. She thought it would be well for midwives to attend the students' cases, so that a qualified person should be in attendance.

In a lucid summary, Sir William Collins pointed out that the Conference were agreed that the ideal should be to secure that no parturient woman should be unattended, or inadequately or improperly attended. There was practically no difference of opinion as to (a) and (c).

In regard to (b), Sir Francis Champneys had warned them against ambiguity, and had questioned the ability of the midwife to render the necessary service during the lying-in period. That was a reason for extending the training.

Then there was the question of the fully qualified nurse working under the six months trained midwife. That she was not willing to do.

The question was how to improve the calling of a midwife so as to make her a competent obstetrician.

The conference closed with the usual votes of thanks.

I think the fight for democratic principles and self-government of our profession, that is being waged at home by the N.U.T.N. is doing the greatest possible service to our cause, and we, who are abroad and too much occupied to give it much attention, owe a very heavy debt of gratitude to its leaders.
