REPORT OF THE UNIFORM COMMITTEE.

*The Chairman ruled out of Order the recommendation of the Uniform Committee, "That the booklet of instructions be issued free, it being the feeling of the Committee that it is the legal responsibility of the Council to issue directions " on the ground that if it was desired to alter a previous decision of the Council notice to rescind that decision must be given in time for its insertion on the Agenda, giving the Council ten days' notice.

Circumstances alter cases. It will be within the memory of the readers of this journal that on an occasion when we argued in this sense the Chairman held that Miss Cox-Davies had conformed to the requirements of the Rules, though she had given no notice to rescind a previous decision, by placing a motion in her own name on the Agenda.

May we remind the Council that they have no jurisdiction to prescribe a "foreign uniform." We presume that by giving permission to the Uniform Committee to incorporate details of the "Foreign Uniform" in the Booklet to be issued, they intended to refer to the uniform worn overseas by Nurses Registered by the General Nursing Council for England and Wales.
