SYLLABUS OF SUBJECTS FOR EXAMINATION OF THE GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

It is understood that there are many who are not aware that the Syllabus of Subjects for Examination for the Certificate of General Nursing was approved by the Minister of Health in May, 1923. This Syllabus contains a preface which gives all information regarding the Preliminary and Final Examinations, and can be obtained from the Registrar, General Nursing Council for England and Wales, 12, York Gate, Regent's Park, London, N.W.1, at a cost of 6d. per copy, or 8d. post free. REGISTRATION OF INTERMEDIATE NURSES.

The only Nurses who are now eligible for registration are what are termed Intermediate Nurses—those who have completed their three years' training and been awarded a Certificate since November 1st, 1919. The term of two years' grace for Existing Nurses has terminated.
