

be allowed, will contain: Two questions on Medical Nursing, of which *only* one must be answered; two questions on Surgical Nursing, of which *only* one must be answered; and six questions on General Nursing, of which *only* three must be answered.

The oral and practical part will consist of an oral examination of twenty minutes in Medicine, Surgery, and Gynæcology, and an examination, both oral and practical, in Nursing lasting half an hour.

The written answers and the oral part of the examination in Medicine, Surgery, and Gynæcology will be marked by Medical Examiners; the written answers on Medical, Surgical, Gynæcological, and General Nursing, and the oral and practical examination in Nursing, by Nurse Examiners.

FOR THE SUPPLEMENTARY REGISTERS.

The Examinations for the Supplementary Registers will follow on the same lines.

MALE NURSES.

In that for Male Nurses, questions on Gynæcology and Gynæcological Nursing will be omitted, and questions on Venereal and Genito-Urinary diseases substituted.

MENTAL NURSES.

The written part of the Examination will consist of two papers, each of two and a half hours.

The written answers (with the exception of those on Mental Nursing), and the oral part of the Examination on Mental Diseases, will be marked by Medical Examiners; the written answers on Mental Nursing, and the oral and practical examination in Mental Nursing by Nurse Examiners, specially qualified in Mental Nursing.

Candidates in the Final Examination for Mental Defectives will not be examined in Sections IX, X, or XI of the Syllabus of Subjects for Examination.

SICK CHILDREN'S NURSES.

The written part will consist of two papers, one of two and a half hours, and one of one and a half hour. The written questions on Children's Diseases, and Infant Feeding, and the oral part of the examination on Diseases of Sick Children will be marked by Medical Examiners; the written answers on Nursing of Sick Children, and the oral and practical examination on Nursing of Sick Children, by Nurse Examiners, specially qualified in nursing Sick Children.

FEVER NURSES.

The written part will consist of two papers, each of one and a half hours.

The written questions on Fevers, and the oral part of the examination on Fevers, will be marked by Medical Examiners. The written answers on Fever Nursing, and the oral and practical examination on Fever Nursing, by Nurse Examiners specially qualified in Fever Nursing.

EXAMINERS, ASSISTANT EXAMINERS, PRESIDING EXAMINERS, AND INVIGILATORS.

For each Examination a Board will be appointed for the whole of England and Wales, composed of

four Chief Examiners, one from each of the Groups of Areas . . . of whom one shall be a Surgeon, one shall be a Physician, and one shall be a Nurse. The said Examiner will be appointed from each Area in the Group in rotation.

Each Board so constituted will elect one of its own members to be Chairman, and will be responsible for setting and marking the written papers of its own Examination. In addition, Assistant Examiners will be appointed from each Area to take part in the practical Examinations.

The Committee also reported that "A List of Teachers has been prepared comprising both Medical Practitioners and Nurses who are engaged in teaching at the Training Schools approved by the Council. Any such Teachers will be eligible to be appointed as Examiner for such subjects as he or she teaches. . . ."

"It will be the aim of the Council, as far as possible, to appoint as Examiners for the General or for the Supplementary Parts of the Register persons who are engaged in teaching nurses for these examinations respectively, and this both in the Preliminary and the Final Examinations."

The Council will appoint a Presiding Examiner at each place where the written Examination is held, and one or more Invigilators will be appointed to assist her.

GENERAL ARRANGEMENTS.

The written Examination will be held simultaneously all over England and Wales.

The dates for the Oral and Practical Examination will be a matter of arrangement at each Examination. Each candidate will be notified as to the place and date, and, if possible, the time when she will have to present herself, on the first day of the written examination.

The Pass List, when approved by the Council, will be published. Each candidate will be notified of the result of her examination, and each successful candidate at the Final Examination will be awarded a Certificate, and furnished with a form on which to make application for admission to the Register.

Optional Examination.

An optional Examination will be held in 1924, for the benefit of Nurses training for the General Part of the Register, who began their training subsequently to July 13th, 1920, and will have completed not less than three years' training before July 1st, 1924. It will cover all the subjects of the General Syllabus, and of the Nurses' Chart attached to it. If a sufficient demand be shown, similar Examinations for the Supplementary Parts of the Register will also be arranged. In the case of Fever Nurses, evidence of two years' training only will be required. In every case it is requisite that the training should have taken place in a hospital approved by the Council.

"Those Nurses who will have completed their training after June 30th, 1924, and before July 1st, 1925, will be eligible for registration as Intermediate Nurses without sitting for the State Exami-
