nations, but should they wish to register by examination, they will have to pass both the Preliminary and Final State Examinations on the same footing as future Nurses."

Existing Nurses.
The Committee stated that "There seems no reason under the Act why an Existing Nurse who has missed the opportunity of obtaining the privileges extended under Section 3 (2) (c) should not apply for admission to the Register under the general rules governing application for admission to the Register after June, 1925. An applicant in that case would have to conform to the conditions laid down in the Rules for Admission to the Register after June 30th, 1925, that is to say, would have to show evidence of age and character, and of not less than three years', or, in the case of a Fever Nurse, of two years' training, in a Hospital in the Council's List of approved Hospitals, and would also have to pass the Preliminary and Final State Examinations.

Recommendation 9. That the Education and Examination Committee be empowered to carry out the Examinations in accordance with the above scheme and to draw up and issue such forms, regulations and instructions as may from time to time be necessary for that purpose."
