This was carried, and was then put and carried as a substantive motion.

The Committee reported that it "does not understand why the Ministry wish for a new Reciprocity Rule, unless it be for the purpose of omitting the words that now exclude Fever Nurses from the Rule. It appears from a communication received from the Registrar of the General Nursing Council for Scotland that they are about to alter their rules on Fever Training, and to make them conform to ours. If so, reciprocal registration of Fever Nurses will be possible, but the Committee has not yet received a definite statement

that this has been done." It was resolved "That the Education and Examination Committee be given power to settle the Reciprocity Rule after the matter has been further considered."

It was also resolved that the following letter be sent to the Matrons of General Hospitals.

DEAR MADAM.

I am instructed to write to you to express the Council's desire that your Training School will, so far as possible, allow Regis-tered Sick Children's Nurses to obtain a two years' course of training in General Nursing. The Council would be grateful if you would assist in this

important matter.

THE CHAIRMAN said that there was not the smallest reason why the information should not be given.

MR. STRATTON inquired whether these ladies would examine the male nurses.

THE CHAIRMAN said that they would examine papers.

In reply to Dr. BEDFORD PIERCE, the CHAIRMAN said that the Assistant Examiners would conduct the viva voce and practical part of the examinations, and also would look through some of the papers if they were too many for the Board to examine.
