### BRADFORD ROYAL INFIRMARY NURSES' LEAGUE.

Seeks Affiliation with the National Council of Trained Nurses.

The Eighth Annual Meeting was held at the Royal Infirmary on Saturday, May 24th, and attended by a very satisfactory number of members.

The President, Miss Davies, Matron, Bradford Royal Infirmary, in her opening address, gave a resumé of the League's activities during the past year, which included the entertainment of six International Students in the early Spring, when a public reception was organised for them and an address of welcome given on behalf of Bradford nurses from the various hospitals and departments of Public Health Services.

### DELAY IN REGISTRATION OF APPLICANTS.

The following correspondence with the Hon. Secretary of the Registered Nurses' Parliamentary Council, on its behalf, was laid before the Council by the Chairman of the meeting.

To Sir Wilmot Herringham, K.C.M.G., C.B., Chairman, General Nursing Council for England and Wales.

SIR,—At the recent meeting of the Registered Nurses' Parliamentary Council, evidence was placed before it of the unreasonable length of time which applicants are kept waiting for registration, in some instances as long as twelve months, thus depriving well-trained nurses of the legal status without which they are unable to obtain professional posts applied for.

I was directed to forward to you, on behalf of the Registered Nurses' Parliamentary Council, its strong protest against these unnecessarily unjust conditions, and to ask you to read this letter at the next meeting of the General Nursing Council for England and Wales, and to express the hope that it will take steps to rectify them.
