## ANNUAL GENERAL MEETING.

H.R.H. the Princess Arthur of Connaught took the Chair at the Annual Meeting on Wednesday, June 25th, and there was a good attendance of the Members. The Annual Report recapitulated, to a great extent, the activities of the Association throughout the year, and, as these have already been fully reported to the Members, as they occurred, in our official organ, we need not refer

to them again.

The accounts for the year showed an excess of income over expenditure of £43 18s. 7d., but it was pointed out that the sum of £231 18s. 4d., received during 1923 for the Memorial Fund, had necessarily been placed in the balance sheet without passing through the income and expenditure accounts, and another from of the money given by the landlord for repairs when we took the lease of 194, Queen's Gate, had been used, so that the sum indicated for expenditure on this item, £66 is. 4d., did not represent the full amount actually spent. The expenses connected with the

Club had been much the same as in previous years.

The Hon. Treasurer drew attention to the fact that the negligence of many Members in paying up the very small Annual Subscription due from them was proving to be a matter of very serious importance in connection with balancing the year's accounts. There are many who, in spite of reminders, allow these arrears to mount up until By-law VIII comes into operation and they have to choose between paying up arrears and losing their Membership. It is obvious that it would be impossible to carry on any Association if all Members adopted this course, and the Treasurer appealed very strongly to the Members to be more businesslike in forwarding the very small subscription which is required of them. By far the greater number of our nurses have become Life Members, and for this reason it is all the more important that the annual Members should meet their liability when it falls due on January 1st of each year.

The expenditure of the Settlement Fund had been £225 7s.  $1\overline{d}$ . in excess of its income, but this was accounted for by the fact that most of the cost of the recent extensive improvements and repairs at the Home had fallen into the 1923 accounts. The Helena Benevolent Fund's expendi-

ture had been £8 16s. 3d. in excess of the income received.
