### THE STATE REGISTERS.

Since our last issue, the State Register of Nurses for 1924, issued under the direction of the General Nursing Council for England and Wales, in pursuance of the Nurses Registration Act, 1919, has been published, price 10s. 6d. It now approximates in size to the Medical Register.

We have also received the Register of Nurses, and the Roll of Midwives for 1924, published under the Joint Nurs-ing and Midwives' Council for Northern Ireland, two slim booklets, admirably produced and printed, the former in a grey cover, price 3s. 6d., and the latter in a true Irish green, price 2s. 6d., both lettered in green.

### THE STATE UNIFORM.

Messrs. Boyd Cooper, 4, George Street, Hanover Square, London, W.I, who designed the State Registered Nurses' uniform, are making it a special feature. Models of the whole uniform are on view in their showrooms, where everything is supplied except the State Registered Nurses' hats and badges. Price list and patterns will be sent to Registered Nurses on application.

At long last Registered Nurses seem within sight of obtaining the protected uniform which may not, under penalty, be worn by all and sundry. We recently saw in the Nurses' Saloon at Messrs. Garrould's, 150, Edgware Road, W., a model of the coat frock, with detachable cape, lined with Royal Blue satin of the same shade as the blue braid on the coat frock. The dark blue overcoat has also touches of blue of the same colour, and dark buttons bearing the Tudor Rose, and the words England and Wales round the border. The coat and skirt, which is designed in the same colouring, is worn with a shirt blouse of Jap silk, with a Regulation tie of Royal Blue silk poplin.

We advise our readers to inspect these models for themselves, and as this uniform, which is only supplied on a permit to be obtained from the Registrar of the General Nursing Council, at 12, York Gate, the sooner these permits are applied for the better.

Messrs. Marshall & Snelgrove, Vere Street, also supply the uniform, but so far it is not on view.
