# GENERAL NURSING COUNCIL FOR SCOTLAND.

### Note of Proceedings at the Meeting held at 18, Melville Street, Edinburgh, on Friday, 24th April.

Sir John Lorne MacLeod, G.B.E., LL.D., Chairman of the Council, occupied the Chair, and nine Members of Council were present.

Amongst the correspondence dealt with was a letter from the Scottish Board of Health approving of the Council's proposal to charge no Registration Fee in the case of Future Nurses. This approval was given only for the period ending December 31st, 1926, when the Board were of opinion that the matter should be reconsidered.

Col. D. J. Mackintosh, submitted the Report of the Education and Examination Committee, and this was approved after some discussion. In terms of the Report, the Burgh Infectious Diseases' Hospital, Motherwell, was recognised for the Fever Nurses' Part of the Register, and Hawkhead Mental Hospital, Glasgow, and James Murray's Royal Asylum, Perth, were recognised for the Mental Nurses' Part of the Register.

Further arrangements were made in regard to the Final Examination. It was decided that the First Final Examination should be held in October, 1925. It was resolved that a Nurse need not be 21 years of age before sitting the Council's Final Examination, but that her name should not be actually placed on the Register until she had attained that age.

It was resolved that the Written Part of the Final Examination for Sick Children's Nurses should consist of two papers, the first to contain one question on Bacteriology, one question on the First Medical Nursing Course, two questions on the Second Medical Course, and two questions on Surgical Nursing, of which six questions the Candidate must answer five, including the one of the First Medical Nursing Course; and that the Second Paper should consist of three questions on Elementary Theory and Practice of Nursing, Part II, and three questions on Dietetics and Cooking, of which six questions the Candidate must answer five.

It was resolved that the Written Part of the Final Examination in Fever Nursing should consist of two papers, the first to contain three questions on Infectious Diseases and three questions on Medical and Surgical Nursing of which six questions the Candidate must answer five, and that the second written paper should be the same as for the Sick Children's Nurses' Examination.

With a view to preparing a Panel of Examiners for the Final Examination, it was arranged that the Registrar should obtain from the leading Training Schools a list of their teaching Staff who might be available as Examiners and should get into touch with these.

The Report of the Uniform Committee was submitted by Miss White, the Convener, and was unanimously approved. This showed that the Committee were still waiting a reply from the General Nursing Council for England and Wales in regard to the proposal to drop the question of Registration of parts of the Uniform at the Patent Office.

The Report of the Registration Committee was approved, and in terms thereof the names of 139 Nurses were added to the Register.

The Minister of Health has approved the following arrangements to take effect on the promotion of Sir A. Symonds, K.C.B., Second Secretary, to be Secretary to the Board of Education :---Mr. E. R. Forber, C.B., C.B.E., to be Deputy Secretary to the Ministry of Health; Mr. L. G. Brock, C.B., and Mr. I. G. Gibbon, C.B.E., to be Principal Assistant Secretaries.
