We are officially informed that prior to the Meeting of the Board of the Royal Infirmary, Edinburgh, held on September 27th, the Managers met Miss A. W. Gill, R.R.C., Lady Superintendent of Nurses, who demits office at the end of the month, and presented her with a Gilt Chiming Carriage Clock,

suitably inscribed, together with a purse of notes.

The Lord Provost, who made the presentation, referred to Miss Gill's devoted services to the Institution and to the valuable work which she had performed during the War, as also on various outside Bodies and Associations connected with the interests of and advancement of the Nursing Profession.

Miss Gill has also been the recipient of gifts and other tokens

of appreciation from the members of the Honorary Staff, the Sisters and other Officials.

The Matron-in-Chief of the Territorial Army Nursing Service, referring to the important services rendered by Miss A. W. Gill R.R.C. to her country during the great war, states in addition to her civil duties of Lady Superintendent of the Royal Infirmary, Edinburgh, she held the position of Principal Matron, T.A.N.S. (originally Organising Matron, Territorial Force Nursing Service.—ED.) from the inauguration of that service in 1908 to the present date, and she served with distinction in both the South African and European Wars.
