VALEDICTORY MEETINGS.

The meetings held under the auspices of the Nurses' Missionary League on October 8th took the form, at the Morning and Afternoon Sessions, of a Day for Prayer and Meditation, conducted by the Rev. M. H. Richmond. Helpful addresses were given on the "Care of the Inner Life" in the morning, when there was also some discussion on difficulties in Prayer, led by Miss Sutherland (St. Bartholomew's Hospital and Madras) and Miss Harrison (Guy's Hospital). In the afternoon the subject of the addresses was "Power and Witness."

The Evening Session was the Valedictory Meeting, to wish God-speed to the 31 members of the League who are sailing to the mission field for the first time. Miss Richardson read a short report, speaking of the past six months as some of the most wonderful in the history of the League, and telling of encouragement in many hospital branches, Seven of the and of new openings in Wales and Ireland. sailing members were on the platform, and they briefly told of the various ways in which they had been led to offer for missionary service. It was a wonderfully interesting narrative, and illustrated the beautifully diverse ways by which God calls his servants. Three mentioned the influence of articles or advertisements in the Nursing Press; one had heard the call through a sermon heard in a village church; to another it had come through her experiences as leader of the Girl Guides; to another through the words of a friend. Very varied, too, was the work to which they expected to go—one to leper work in India, others to Egypt, India, China, New Zealand. One and all they asked for the prayers of their fellow-members in the homeland.

The evening closed with an address by the Rev. M. H. Richmond, on the words "I will make you to become fishers of men," in which he urged the need for more personal work in seeking to win others to a knowledge of lesus Christ as Services and as Tord

GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

The Sixty-second Meeting of the General Nursing Council for England and Wales was held on October 16th at 20, Portland Place, W.I, SIR WILMOT P. HERRINGHAM, K.C.M.G. (Chairman of the Council), presiding.

Minutes.

Before the Minutes of the Council Meeting held on September 18th, were confirmed, THE CHAIRMAN stated that the Agenda for that Meeting (produced) did not contain the grounds of the indictment on which the name of Mabel Tribe (No. 23880) was removed from the Register. He asked leave of the Council to add to the Minutes of the Meeting the statement that she had been twice convicted for obtaining goods under false pretences. This was agreed, and the Minutes were confirmed

THE CHAIRMAN further stated that it was desirable that the removal of a nurse's name from the Register should be publicly notified. Following the practice on a former occasion he proposed to notify the press that this nurse's name had been removed from the Register. This was agreed.

Removal of Name from Register.

The following statement was handed to the members of the press in the room:—"That the name of Miss Mabel Tribe, Registration Number 23880, has been removed from the Register of the General Nursing Council for England and Wales for being twice convicted and imprisoned for obtaining goods under false pretences.'
